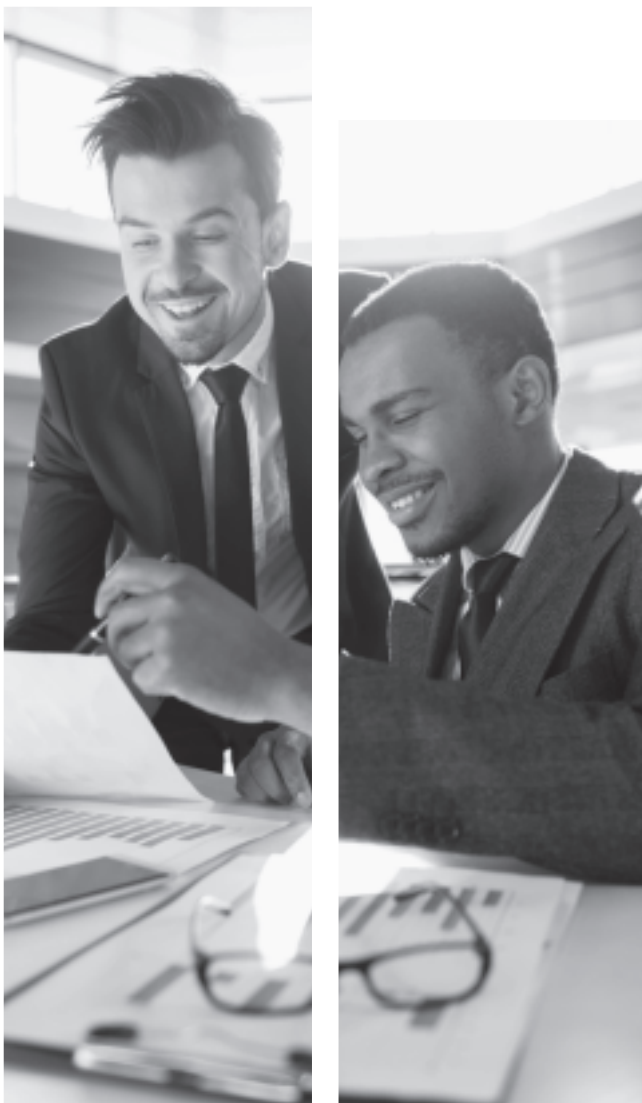

OUR CONTRIBUTIONS

AND SOCIAL RESPONSIBILITY

1. SASLAW PRO BONO NPC

From the inception of the project launched by SASLAW at the Labour Court in Braamfontein, the Firm has demonstrated its commitment to promoting access to justice which the project provides, in the form of Pro Bono hours spent in the Advice Centre at the Court and in respect of Pro Bono matters taken on by the Firm. In this way over the four years of the project a significant number of Pro Bono hours have been accumulated and a significant number of indigent litigants assisted.

In addition the Firm has made regular financial contributions to SASLAW and the non-profit company which administers the project. The Firm's Managing Director, Richard Maddern, is currently the President of SASLAW and a Director of SASLAW Pro Bono NPC.

2. HABITAT FOR HUMANITY BUILD

As explained on their website (www.habitat.org.za), Habitat for Humanity is supported by thousands of individuals, churches, foundations and corporations which assist in the raising of funds for the building of low cost houses and then participating in the actual building process itself. The strength of the programme lies in the fact that houses are not just given away, but rather that families who qualify for the houses repay to Habitat a portion of the cost of the house without interest. That money is then utilised to contribute towards a portion of the cost of the next build and so on. This creates a system through which more and more people gain access to affordable houses. Habitat also integrates these families into the community by providing them with courses ranging from budgeting to basic administrative skills.

Wright Rose-Innes is very aware of its corporate social responsibilities. As such the partnership with Habitat for Humanity in the pursuit of building simple, decent, affordable homes for people in need, was a most worthwhile project. Wright Rose-Innes took on the challenge of a build and successfully completed a house on the 27th of October 2006, in Katlehong South, Germiston (where the Firm had practiced for over a century). Not only was this a most rewarding experience for the Firm, but it was also an adventure for all the staff (most of whom had never in their life held a trowel, mixed cement or laid a brick) who participated on a daily basis. This certainly was also one of the most uplifting team building exercises in which the Firm has invested.

On the final day, Paul Rademan, Wright Rose-Innes's Senior Partner at the time, handed over to the recipient, keys to the house and scissors with which to cut the ribbon. She was also presented with a Bible and a Cross, together with a supply of groceries, and various other donations in the form of furniture, curtains and plants for the garden, from the Firm and its staff. The recipient's husband passed away at the beginning of this year and it was his dying wish to build a house for his wife. In her eyes, this amounted to the fulfillment of a deceased man's last promise to his wife. She was overcome with emotion and gratitude.

This humbling but exhausting experience will remain in the minds and hearts of all at Wright Rose-Innes. We are proud to have positively contributed to one grateful family as well as to our growing and developing nation.

3. CHARITY GOLF DAYS

Wright Rose-Innes has also hosted three Charity Golf Days :

- In 2002 we raised over R20 000 and these funds were used to furnish and decorate the children's room for the Family Violence, Child Protection and Serious Sexual Offences Court, based in Edenvale.

- In 2003 we raised R18 000 for the Salvation Army's Strathyre Girls Home. This is a home that houses aids orphans and gives them a fantastic start in life by caring, nurturing and educating them.
- In 2004 we raised R23 000 for CASA CARITAS. This is a home that caters for the needs of severely mentally and physically handicapped people of all races and creeds.

4. MENTORING PROGRAMS

In 2008, the Directors of Wright Rose-Innes embarked on a mentorship program, organized by the Law Society, where practitioners (from previously disadvantaged backgrounds) who require assistance in learning, are given that opportunity. They are allocated to an experienced practitioner and then spend 20 hours with that practitioner during which time a formidable amount of skills can be transferred.

The program has been very successful and the learner practitioners are very pleased with their new skills.
